Glosarium Istilah Bahasa Sasak

- Balesan* : Istilah dalam masyarakat Sasak dalam menyakini segala sesuatu yang dilakukan dengan baik/buruk akan memperoleh hasil yang baik/buruk yang berdampak pada diri sendiri.
- Bekal* : Istilah bahasa Sasak yang memiliki arti keyakinan positif kepada Allah
- Belian* : Dukun Sasak yang memiliki kemampuan supranatural dalam mengobati penyakit
- Jampi* : Media penyembuhan dengan menggunakan mantra yang berbahasa Sasak, atau Al-Quran
- Kuase Allah* : Istilah bahasa Sasak yang artinya Kuasa Allah SWT terhadap segala peristiwa dalam kehidupan manusia
- Lupaq Diriq* : lalai terhadap diri sendiri
- Nasi abang* : Istilah bahasa Sasak yang artinya Nasi merah
- Nasib* : Penerimaan diri masyarakat Sasak terhadap kondisi yang baik/buruk dan Takdir yang telah ditetapkan oleh Allah namun tetap melakukan upaya untuk mengubah kondisi tersebut menjadi lebih baik dan tetap berserah diri kepada Allah atas hasil yang diperoleh.
- Oat* : Istilah bahasa sasak yaitu memiliki arti obat. Obat disini baik obat medis dan tradisional
- Syarat* : Suatu prasyarat yang dilakukan oleh masyarakat Sasak untuk mendapatkan hasil yang diinginkan. Biasanya penggunaan istilah ini cenderung prasyarat dalam mengatasi masalah yang supranatural atau bersifat *ghaib*
