CONTRACTUAL AGREEMENT

On this day: 27 December 2019. We, the undersigned below:

1. **Prof. Dr. Achmad Nurmandi, M.Sc.** : Vice Rector for International Affairs and Cooperation of Universitas Muhammadiyah Yogyakarta. Hereinafter referred as the **First Party**.
2. **Dr. Dimas Bagus W, SE., M.Ec, CRM** : As the participant of UMY Scholarship (**Visiting Fellow Program**) 2019/2020 at Universitas Muhammadiyah Yogyakarta. Here in after referred as the **Second Party**.

The **First Party** and the **Second Party** have agreed to bind themselves in an implementation agreement of UMY Scholarship (**Visiting Fellow Program**) 2019/2020, starts from 16th February 2020 to 23th February 2020 with the following terms and conditions:

- a. The **First Party** permits the **Second Party** to run the UMY Scholarship (**Visiting Fellow Program**) 2019/2020, offered by Universitas Muhammadiyah Yogyakarta, Indonesia. The **Second Party** should make a report on the activity result referred to in the point "a" above.
- b. The **First Party** provides the first phase of funding assistance; Rp. 17.500.000,00 (70% of the total funding; Rp. 25.000.000,00 and the second phase is Rp. 7.500.000,00 (30% of the total funding) will be granted after the **Second Party** collects the progress report.
- c. The progress report consisting financial and activity report should be submitted to Cooperation and Partnership Office by the **Second Party** maximum two months after the program started.
- d. The final report consisting financial report, activity report, and a form of accepted journal proposal indexed in Scopus should be submitted to Cooperation and Partnership Office maximum a month after the program ended.
- e. If the **Second Party** does not enforce the provisions mentioned in the point "c" and "d", the **Second Party** should return all funds as mentioned in the point "b".
- f. The matters which are not covered in this agreement should be stipulated together in the deliberations.
